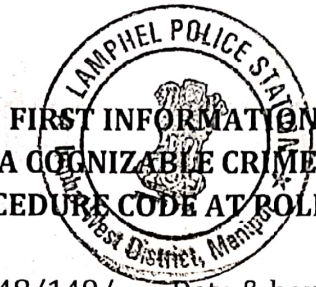

2. Money in cash Rs 1 lakh 20 thousand inside my almirah
3. Some imported dress like shawl and magla etc worth around 80 thousand
4. Household items worth around 1 lakh

So, I therefore request you to take up legal steps by registering an FIR.
