It is to inform you that on 4<sup>th</sup> May 2023 at around 8:00 pm volunteers of suspected Arambai Tengol, Kangleipak Kanba Lup (KKL), Meitei Leepun numbering around 1000 attacked my residential quarter at Langol Housing Complex, Type III/ D-13 and looted all my movable household properties including my Honda Activa bearing Regn. No. MN1R-4785 and important personal documents. The approximate value of all the looted properties is around Rs.4,50,000/- (four lakhs fifty thousand) only.

I therefore request you to take legal action against the culprits at the earliest by registering an FIR.
