vandalised all my properties and stolen away
all my valuable items in quarter and it worths
about 15 (fifteen) lakhs. I cannot report the
matter to the concerned Police Station due to
the prevailing ethnic clash between Meitei and
Kuki in Manipur.

I therefore, earnestly pray you to
kindly take up legal action in this regard.
