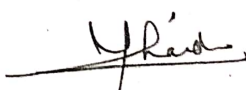

Sirs, With due respect, I have the honour to state that due to ethnic clash between the Tubals and Meiteis in our State, many private houses and govt. residential quarters at Imphal has been torched and looted. In which my govt. residential quarters located at Lamphelpat Imphal (Type II/B-26) has also been Vandalised, torched and looted with a property worth Rs. 8 lakhs. Due to this me and my family are compelled to run for our lives and take refuge at 86 Bn. CRPF Lamphelpat on 4th May 2023 at around 10:00am and later at Lamha on the 9th May 2023.

So, in this regard I would like to file an FIR report and request you to kindly look into the matter and book the culprit as per the law.
