Subject: Complaint against arson, looting, and destruction of our house.

Sir,

I would like to report the following complaint of looting, violent destruction of our house and property at Langol Housing Complex Type II/C-33,Imphal West on 04.05.2023 at around 11:45 looting whatever household items, clothes, furnitures, utensils, sintex, etc. (Enclosed list of stolen items and destroyed items) and arson of my vehicle parked at Paite Veng, Sangaiprou on 03.05.2023 at around 8:30 PM by an unruly large mob of miscreants where I was taking shelter at that time of incident and they where shouting against us in the locality at paite veng, Sangaiprou. Frist they started pulling us out of the house and even beat us using foul languages, snatch my office bag which include laptop, wallet, ID etc and burnt my vehicles parked inside the compound. We ran for our lives to a safer place after narrowly escape from the mob and then were rescued by the army at night itself. We have been rendered homeless and our house is no longer fit for occupation after the looting and destruction.

In view of the above, it is requested to register an FIR on the aforementioned case.
