Subject: Complaint against arson, looting, and destruction of our house.

Sir,

I would like to report the following complaint of arson, looting, violent destruction of our house, vehicles, properties on 03.05.2023 at around 8:30 PM at Paite Veng, Sangaiprou by an unruly large mob of miscreants. They attacked our house by pelting stones and shouting against us in our locality at paite veng, Sangaiprou. First they started pulling us out of the house and even beat us using foul languages. They vandalized our properties and burnt our vehicles parked inside our compound. After looting whatever household items, clothes, furnitures, utensils, sintex, etc. (Enclosed list of stolen items and destroyed items). We ran for our lives to a safer place and then were rescued by the army at night itself. Even on 4.05.2023, the miscreants continued to steal household items, water sintex, sheets, etc. kept at the compound. My shop where I run my pharmacy (V.K.PHARMACY) was also looted and destroyed which is the only source of income I had. We have been rendered homeless and our house is no longer fit for occupation after the arson, looting and destruction.

In view of the above, it is requested to register an FIR on the aforementioned case.
