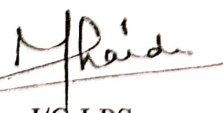

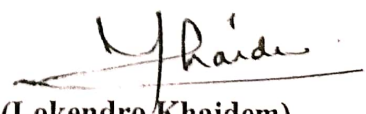

Sir, I would like to state that on 4th May, 2023 starting from 10:00 am onwards unruly mob numbering to about 800/1000 assembled at Paite Veng, Imphal with an intention to cause harm and destroyed property in the locality armed with deadly weapons like sticks, iron rods and clubs. The assembled mob turned violent and started vandalising, ransacking and burning houses in which my house, swift car vxi were burnt down to ashes. The approximate property worth is Rs 1 crore.

In this regard I would like to request you to kindly take necessary legal actions against the unruly mob at the earliest.
