

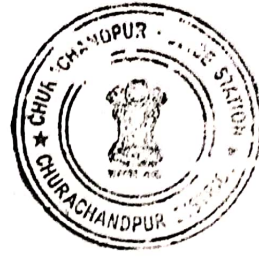

Sir,  
I would like to state that on 4th May, 2023 starting from 10:00 am onwards unruly mob numbering to about 800/1000 assembled at Paite Veng, Imphal with an intention to cause harm and destroyed property in the locality armed with deadly weapons like sticks, iron rods and daos. The assembled mob turned violent and started vandalising, ransacking and burning homes in which my home, furniture, two wheeler, were burnt down to ashes. The approximately property worth is Rs. 40 lakhs.
