



I am to bring to your notice that on the 4th May 2023, between 11am to 5pm, my residence was attacked by a group of people numbering about 200-300 suspected to be members of Arambai Tengol , Meitei Leepun and others

They broke my gate and looted valuable properties from the house (approx) Rs.2,03,56,000/- ,ruppees Two crore three lakhs fifty six thousand) only and then burned down all the remaining things including the building. Amidst the criminal activities, I along with my family members managed to escape through the backdoor and fled to the Lamphel CRPF camp for our safety.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes
