Today i.e. 11/6/2023 at 5.55 pm, received information from mike 30 (SP-Control room-IW) that on the same day at around 2.50 pm, one Bolero white in colour bearing registration no. MN01AK-2836 driven by an unknown driver coming from Malom side towards Imphal had knocked down one unknown pedestrian in front of Godrej Interio, Sangaiprou, along Tiddim road, due to rash and negligent driving on the part of the unknown driver of the Bolero Jeep. As a result of which the unknown pedestrian received injury on his person and evacuated to Asian Hospital for medical treatment and the Bolero Jeep got partly damaged.
