Today i.e. on 12th June, 2023 at 6:30 pm, received an information from SP-IW control room that on the same day at about 6:00 pm, some agitators are coming towards Langol Pheipijang side with intent to set on fire of houses near Langol Pheipijang areas. Immediately a combine team of Lamphel police proceed toward the location.

On reaching by the combine team at the Langol Pheipijang area, it was found that about 1000 agitators consisting of men and women folk of different age groups etc. storms and burnt down the houses of suspected Kuki inhabitant. To resolve the unlawful assembly and the riot, the police team had announced to stop and disperse themselves within 5(five) minutes as per order of the Executive Magistrate. But the mob did not obey the command /order and became violent. As there is no alternative means the team fired tear gas shell on them to control the riot. Later, it became under control.

Hence a suo motu case under FIR. No. 622(6)2023 LPS u/s 147/148/149/436/427/506-IPC has been registered for investigation.
