Officer-in-charge **Lamphel Police Station** Imphal West District, Manipur Today i.e. on 12th June, 2023 at 8:40 pm, received an information from SP-IW control room that on the same day at about 8:00 pm, some agitators storm towards Langol Vaiphei Enclave and vandalized one suspected Kuki inhabitant house. Immediately a combine team comprising a Column of 12 Grenadier, 172 Bn BSF, Lamphel Police and combine team of CDO-IW proceed toward the location.

On reaching at the spot by the combine team it was found that about 2000/3000 agitators consisting of men and women folk of different age groups were vandalizing and destructing one suspected Kuki inhabitant house by pelting stones etc. To resolve the unlawful assembly and the riot, the combine team had announced to stop and disperse themselves within 5(five) minutes as per order of the Executive Magistrate for unlawful assembly and violation of curfew imposed by the District Magistrate. But the mob did not obey the command /order and became violent. As there is no alternative means the team fired tear gas shell on them to control the riot.

Hence a Suo motu case under FIR. No. 623(6)2023 LPS u/s 147/148/149/427/151/188/506-IPC has been registered for investigation.
