With due respect, I, the undersigned beg to report you that on 12/06/2023, at about 5:00 p.m., some unknown person numbering about 100 have cause damage to my G+3 residential building located at Langol, near Shija Hospital. At that time my driver, namely Jilangamba and my caretaker, Bijen were staying at the residential building and they were brutally beaten and sustained grievous hurt at their body. They were admitted at Raj Medicity, BOC for treatment. Though presently the name in the Land record is still in the name of one Dr. Seiminlien Vaiphei, S/o Thanglun Vaiphei of Changoubung Village which is due to the land transfer restriction imposed by the Government of Manipur.

That the said land was purchased by me on 28/04/2023 by executing an agreement to sale with the said Dr. Seiminlien Vaiphei and me. In the said incident my properties worth about Rs. 50,00,000/- (Rupees Fifty lakhs) only has been destroyed.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may kindly cause the arrest of the unknown miscreants and registered an FIR against them who are involved in damaging the said G+3 residential building.
