



That in the intervening on 04th May, 2023 around 1500 Hrs, some unknown miscreant completely destroyed/vandalized and looted my all properties of my house which is situated at "House No. 38, Sector-B, Type-II, Langol Housing Complex, Langol under P.S. Lampel, Imphal West, manipur" and take away all my valuable household items/ornaments which was kept at my house. List of items enclosed as Appendix-"A". During the mayhem period my family took shelter at the Head Quarter 86-Bn CRPF.
