property in the locality armed with deadly weapons
live sticks, iron rods and etc. The assembled mob turned
violent and started vandalising, ransacking and burning
houses in which my home, furniture, three two-wheeler
and three four-wheelers were burnt down to ashes.
The approximate property worth is Re. 5 Crores
