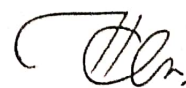

I would like to state that, On 04/05/2023 at about 1:00 Pm.
my allotted Quarter No. D-96 Zone 1 of National Games Village,
Imphal west, Manipur was looted by unruly mob numbering around 50 to
70 persons. The following assets/property looted is estimated below.

1. Furnitures and Electrical appliances - ₹ 5,50,000/-
2. Clothing and utensils - ₹ 4,00,000/-
3. Animals (10 Goats + 8 Rabbit + 2 dogs) - ₹ 1.30 lakhs

That, the said incident occurred under Lamphel Police Station,
Imphal west but it is not conducive to lodge and FIR at Lamphel Police
Station due to prevailing Law and order situation which also leads to
late in lodging an FIR. I therefore requested you to kindly register
Zero FIR on the above incidents at your PS.
