Subject: Complaint against arson, looting and violent destruction (Zero FIR)

I would like to make the following complaint of arson, looting and violent destruction of my house and properties on 3rd May, 2023 at about 8:30 pm where a large number of miscreants attacked our house by pelting stones and shouting slogans against us in our locality of Paite Veng, Sangaiprou, Imphal West. First, they forcibly entered the house, vandalized and burnt our vehicles parked inside the compound. Fearing for the lives of our family, we ran out of the house and took shelter in safer places. After looting whatever household items inside the house- utensils, furniture, bathroom appliances, electrical gadgets, mattresses, sintex water storage tanks, almirahs, TV sets, laptop, desktop computer, etc kept inside and outside of our house, they burned down the house. The looting and destruction continued on and lasted upto 5th May, 2023. Now we are rendered homeless as our house is no longer fit for occupation after the arson and looting of our properties. Now we are displaced and have taken shelter in safer places. In view of the above facts, it is requested to register an FIR on the above mentioned case.
