



I the undersigned have the honour to state that large number of

groups stormed to all "MEITEI" inhabited areas of Moreh Town on  
3rd day of May 2023 at around 4:30 pm. The said unidentified groups  
vandalised my house/shop and looted all valuable items as well as  
all my construction materials. In that unfortunate incident, I have  
lost a total amount of Rs. 40,00,000/- (Forty Lakhs) app. After  
the said unfortunate incident/mob violent, my family are fleeing  
our village and my family is taking shelter at Imphal West.
