

I, the undersigned have the honour to state that large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Suspected Kuki militants groups stormed to all Meitei inhabited areas in the state from 3rd day of May 2023 onward.

In this incident, the said unidentified Kuki Terrorist looted my heart earned assets and destroyed my House located at Kanto, Prem Nagar Leimakhong Imphal West.

In that unfortunate incident, I have lost a total amount of Rs. 46, 76,200/- (Rupees Forty Six Lakhs Seventy Six Thousand Two Hundred) only after the said unfortunate incident/mob violent.

It is therefore, request you to process for recover my heart earned assets and take necessary legal actions against the accused persons involved, as per law of the land at the earliest.

I shall be grateful for your kind co-operation and necessary actions.
