

**Subject:- FIR on mob Violence, murder, theft and arson at Khongsai Veng, Laipham
Khunnou, Imphal East on 4th May, at 3 Pm.**

Sir,

This is to report that on the 4th May at around 3 pm a belligerent mob of Meitei community numbering around 3000 stormed the gate of Khongsai Veng and engaged in indiscriminate arson, looting, theft and murder.

In the incident, all properties at my permanent residence house No. 10 (ten) were destroyed burned or looted.

Details of properties lost are:-

1. Immovable property : House building worth 55 Lakhs
2. Movable Property:
 - (a) Gold & Jewellery : 30 grams of Gold
 - (b) Granary and grain: 4 Bags of rice.
 - (c) Documents : IXth Certificate of Veideikim Lupheng
 - (d) Vehicle : Activa 6G (MN065SE9708)
 - (e) Furniture : 4 almirah, 5 bed, 10 chairs, 1 sofa set, 6 tables
 - (f) Traditional Ornaments: 3 Khibas (Beads)
 - (g) Modern and traditional gavments : Worth 5700/-
 - (h) Electronics : 4 Smart Phones, Tv, Fridge, water dispenser,
 - (i) Cash : 3.5 Lakhs
 - (j) Bank Passbook: 5 nos.


The total value of properties lost at my residence is about 80 lakhs .
