mob attacked by thousands of Meitei people.
As a result, my house and properties were
destroyed and burnt. My house No - 126 (Re
was also destroyed by the mob, that
included the followings.

1. Movable properties :-

- Gold & Jewellery - 3 gold tola
- Granary and grain - 20 bags
- Furniture - T.V stand / sofa sets / 3 beds / 2 wooden
Almerah
- Traditional ornament - and Traditional garment
- Vehicle - Alto car, MNO182496
- Electronic items
- Cash - Rs 1.50 Lakhs

Total loss of properties at my residence would
be above Rs 20 Lakhs approx

It is therefore kindly requested to take necessary
legal action to arrest the culprit involved in the
incident at the earliest in the interest of Justice
