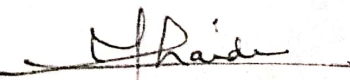

Lamphel Police station was under mob attacked
by thousands of meitei people.

were burnt and destroyed completely.

g) Traditional ornaments - and Traditional garments - etc

h) Gas book - Misao gas Agency 2 Books

i) Cash - 5 Lakhs 50 Thousand
