





Subject: FIR on destruction of Khongsai Veng, House No. 44, Imphal East on 4th May, 2023 at 3:00 pm.

Sir,

I am to state that, on 4th May, 2023, at about 3:00 PM, our locality Khongsai Veng, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of a Meitei Organisation i.e. **Arambai Tenggol, Kangleipak Kanba Lup** with an intend to murder.


As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house **No. 44** (Rented House) was also destroyed by the mob along with 1 Nos. of Two Wheeler bearing Registration No. **MN06SD4037**, Misao Gas Card along with Cylinder, 1 set of Computer along with Two Cannon Printer and many properties were burnt and leftovers were looted.


Total loss of estimated properties burnt and looted would be above **Rs. 2, 00,000/- (Two Lakhs)**

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.
