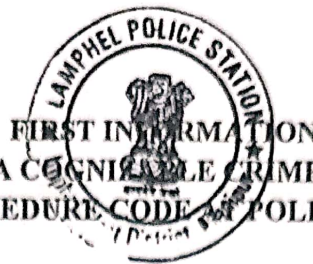

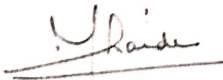

Sir, I am to state that, on 11th May 2023, at about 3PM, our locality Khongai Teng Laipha Khunou, under Lamphel Police station (Lamphel West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the nuclei community with an intent to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. 95 (Rent/Permanent residence) was also destroyed by the mob. Many properties were burnt and left over looted.

Properties looted, burnt and destroyed included:-

- (1) Immovable properties like house having
- (2) Movable properties
 - (a) Gold & jewelry: 50g Gold & Necklace
 - (b) Granary and grain: 5 nice bag, dal, Sugar, drinking beverage
 - (c) Documents
 - (d) Vehicles: Activa 6g (Two wheels)
 - (e) Furniture: 3 beds n mattress, dressing table, dining table n chair
 - (f) Traditional ornament: 150 ponue (Phanek),
 - (g) Modern and traditional garments: 12 blankets, 400 sets of clothing
 - (h) Gas bottle: Mixco Gas 5 cylinder
 - (i) Electronic items: Fridge, smart TV, washing machine, Fan,
 - (j) Cash: Rs 85 thousand.
