



I am to state that, on 4<sup>th</sup> May 2023 at about 3: 00 pm, our locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic rifles, SBBL, knives, etc.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. Among which my house No. 122 (rented) was also destroyed by the mob, many properties were burnt and leftovers were looted.

Lists of properties (both immovable & movable) looted, burnt and destroyed are given below:

1. Gold & Jewellery includes 5 gold necklaces, 2 gold chain
2. Furniture includes 4 Almirah, 3 Dressing Table, Gas cabinet, 4 Bed, Drawer-1, 3 Sofa set, 7 baggages, 2 shoe racks, dining sets & tv tables.
3. Traditional ornament includes- 4 necklace (Khiba)
4. Misao Gas 5 connection, Gas cylinders-08 nos and 2 stove.
5. Electronic items- one Television, microwave, one Fridge, one Washing machine, Geyser, HP Printer, one acer laptop.
6. Cash- 2 lakhs
7. Mountain bicycle.
8. Documents-all educational certificates of all the families, Bank passbook/cheque book.
9. kitchen cabinet with utensils worth Rs 2.5 lacs.
10. Clothing, dresses & shoes of all the families worth Rs 3 lakhs
11. Grocery shop with all the materials and groceries worth Rs 5 lakhs.

The approximate total loss of properties would be Rs 80 lakhs.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
