Sir,

I am to state that on 4th May 2023 at about 3pm, our locality Khongsai Veng, Laipham Khunou, Under Lamphel Police Station (Lamphel West and falling under revenue of Lamphel East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei Community with an intend to Murder.

As a result, many houses and properties were destroyed and burnt to ashes. My house no. 57 as permanent residence was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed included:-

My house, Gold and Jewellery such as Earring, necklace, ring and bracelet. Grain bags, documents - Indian Passport and Land Patta. 2 Vehicles Activa MN01A1925 and Kinetic MN01A0849. Furniture which includes sofa set, 5 wooden bed, 3-wooden almirah, 3-dressing table, 3-steel almirah, 4-study table. Traditional ornaments namely SKhraba, 50-Saiphkhy, 1-whapped round. Gas book - 1 Manipur Police connection. Electronic items namely T.V, Refrigerator, oven, induction, 1-cupboard, 1-tablet, 2-Iphone, washing machine and Laptop. 50 Cash 15 lakhs and utensils, water pipe and pump, 6-Dress and clothes for 8 family members.

Total loss of properties at my residence would be above Rs 2 Crore

It is therefore kindly requested to take necessary legal action to arrest the culprit involved. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to save myself and my family from the rioters.
