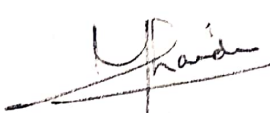

Subject: Complaint Report.

Sir,
I am to state that, on 4th May 2023, at about 3pm, our locality Khongpui Veng, Laiphom Khunou, Under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to Mertei community with an intent to murder.

As a result, many houses and properties were destroyed and burnt to ashes. My house no. 60 staying in rent was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed include:-

Eating, Necklace, Ring, 5 bags of grammy and grains, furniture which includes sofa set, 3 bed, 3 almitah, Dressing table, study Table, Dining table and kitchen almitah, Traditional ornaments namely 2 K^ox 40 - Saipikhu, 86 wrapped round, Electronic items such as T.V, Refrigerator, Oven, induction, Juicer and washing machine and it also includes utensils, water pipe, sintex, Dream and cloth for 6 family members.

Total loss of properties at at my residence would be above Rs 40,00,000

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to save myself and my families from the rioters.
