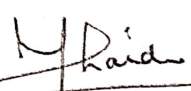

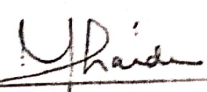

Subject: Complaint report.

Sir,

I am to state that on 4th May 2023, at about 3 PM, an locality
Khangpui Veng, Laiphom Khunore, under Lamphel Police Station (Smphe
West and falling under revenue of Smphe East) was under mob
attacked by thousands of unknown miscreants belonging to the
Kuki community with an intent to murder.

As a result, many houses and properties were destroyed
and burnt to ashes. My house No. 67 staying in Kent was
also destroyed by the mob, many properties were burnt and
left for looted.

Properties looted, burnt and destroyed included my house -
Gold barning, Necklace, Ring, Jewellery and grain & bag,
2 wooden bed, 2 wooden Almirah, 1 Dressing Table, Dining
Table, Kitchen Almirah, traditional ornament - 2 - Khiba,
20 - scrap metal, 70 - wrapped round, T.V, Refrigerator,
Stove, Oven, induction, washing machine, utensils, sink, hot
water pipe and pump, shoes and cloth for 2 family member.

Total loss of properties at my residence would be
about Rs. 15,00,000.

It is therefore kindly requested to take necessary legal action to
arrest the culprit involved in the accident - at the earliest
in the interest of justice. I hereby lodged my complain at
Kangpokpi Police Station as I had fled from my residence to
save myself and my families from the violence.
