



Subject: Complaint Report

Sir,  
I am to state that on 14<sup>th</sup> May 2023 at about 3 P.M, our locality Khongbi Veng  
Lampham Khunov, under Lamphel Police Station (Imphal West and falling under revenue  
& Imphal East) was under mob attacked by thousands of unknown miscreants  
belonging to Meitei Community with an intent to murder.

As a result many houses and properties were burnt down to ash.  
My house No. 58 was also destroyed by the mob, many properties were  
burnt and left in ruins. Properties lost, burnt and destroyed include  
my house, LED T.V., 4-bedded bed, sofa set 4, Dinner set 8, dining table &  
bridge-1, washing machine-1, Almirah-3, freezer-2, dressing table-2,  
ceiling fan, Sinter, 1-two wheelers, 600 stone, dress and clothes for 8 members  
jewellery, cash - 3,50,000.


Total loss of properties at my residence would be at Rs 1 crore.

It is therefore kindly requested to take necessary legal action to arrest  
the culprit involved in the incident at the earliest in the interest of  
justice. I hereby lodged my complaint at Kangpokpi Police Station as I  
had fled from my residence to save myself and my families from  
harm.
