

Sir, I am to state that on 14th May 2023 at about 3pm, our locality Klonglai Veng, Daiphram Khuner, under Lamphel police station (Imphal West) and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intent to murder.

As a result my house and properties were destroyed and burnt to ashes. My house No. 86 was also destroyed by the mob, many properties were burnt and left over lost. Properties lost, burnt and destroyed includes my house, Gold earring, Ring, bracelet, 8 bags of grain, dark Patta T-shirt - 1490, white car, sofa set, 3-wooden chairs, 2-dinning table, 2-study table, Dinning table, Kitchen Aluminium, 3-chairs, 30-Scripithup shawl, 70-wrapped board, T.V, Refrigerator, Oven, Induction, Trench, washing machine, Cash - 20 Lakhs, utensils, water pipe and pump, Sinter, dress and clothes for 4 family members - Total loss of properties at my residence would be above Rs 2 Cro.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi station as I had fled from my residence to save myself and my families from the rioters.
