

Subject: FIR on Destructions of Khongsai Veng, Imphal East, PINO. 78,
on 4th May, 2023 at 3:00 Pm by Valley base miscreant.

Sir,

I am to state that, on 4th May 2023, at around 3 Pm, our locality Khongsai Veng, Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. 78 (Permanent residence) was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed included:-

- (1) immovable properties like House having **2 Storey Wooden house**
- (2) Movable properties
 - (a) Gold & jewelry. **6 tola (24 san), 2 necklace (10 san each), 2 earring (3 san each), rings (5 san each)**
 - (b) Granary and grain. **180 bags of rice, 2 bags of dal**
 - (c) Documents. **Paddy field patta (1 pari and loukhai), 3ATMS, IDS**
 - (d) Vehicles. **Activa 125 (MN01 6748)**
 - (e) Furniture. **9 Beds, 2 sofa sets, 5 wooden almirah, 1 dinning set, 1 tv box**
 - (f) Traditional ornament. **5 traditional necklaces, 2 gong, 5 pairs of bangles**
 - (g) Modern and traditional garments. **10 traditional vest coats, 60 traditional wrap-around, 4 coats**
 - (h) Gas book. **03**
 - (i) Electronic items. **2 TV, Refrigerator, washing machine, 2 micro ovens, desktop computer, laptop,**
 - (j) Cash. **5,00,000/- (Saving + Marup)**
 - (k) Kitchen : Kitchen Almirah + Utensils
 - (L) Wooden Store House

Total loss of properties at my residence would be above Rs. **1,20,00,000/-**

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at kangpokpi Police station as I had fled from my residence to safe myself and my families from the rioters.
