

Sir, I am to state that on 4th of May 2023, at
around 3pm, our locality at Khongrai Vng, Laiphram
Khunou, under Lamphel police station, Imphal west was
under mob attack & set Houses on fire with an
intent to kill.

My House no. 107 was also set on fire
and the property inside were looted by Arsonists.

Properties looted are as listed below:

- i). Gas stove set with 3 cylinders.
- ii). 1 Refrigerator, 1 Washing Machine,
- iii). 2 Double bed with mattress & cushions.
- iv). 1 Sofa set with cushion.
- v). 1 steel & 1 wooden Almirah.
- vi). 1 TV set
- vii). 3 Syntax - 500L each.
- viii). Miscellaneous items.

Total lost of properties at my residence
would be around ₹ 1 crore inclusive of my
House being set on fire.

I therefore kindly request to take necessary legal action to arrest the culprit involved at the earliest. in the interest of justice. I hereby lodged my complaint at Saparmaina Police station as I had fled my residence to save my life & that of my family.
