Sir,

I am to state that, on 4th May 2023, at about 3pm, our locality Khongsai Veng, Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei Community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house no. 148 (permanent residence) was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed include :-

(1) Immovable Properties like House having 1 flat.

(2) Movable Properties

(a) Gold & Jewelry : 1 gold earring (pair), 3 gold necklaces, 2 silver watches.

(b) Grains and Grain : 50 bags rice

(c) Documents : House patta, educational certificates, voter-card, Pan-card, Aadhar card. etc

(d) Vehicles : 1 car (maruti 800 AC, MNO3AOS 38), 1 activa (MNO1E454)

(e) Furniture : 3 Almirah, 2 dressing table, 4 sets of sofa, 3 tables, 6 beds. etc.

(f) Traditional Ornament : 6 traditional necklaces, 2 traditional Gonggr.

g) Modern and traditional garments :

Mattress, Blankets, Carpets, school uniform etc

h) Gas Book : Misao Gas Cylinder (6), Gas stove (3) .

i) Electronic items : Samsung TV, 1 laptop, washing - machine, Refrigerator, 2 water pump, 5 Fan .

j) Cash : 2 lakhs 50 thousands .

k) Carpentry machine, 8 sinker

l) 1 dog, 13 hens, 7 ducks .

Total loss of properties at my residence would be above Rs 3.5 crores .

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice . I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to save myself and my families from the rioters .
