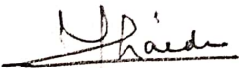

Sir,
I am to state that, on 4th May 2023, at about 3PM, our locality Khongsai Veng, Laiphom Khumou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intent to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My houses no. 56 Rent was also destroyed by the many properties were burnt and leftover looted.

Properties looted, burnt and destroyed included

- a) Gold & jewelry - Gold necklace.
 - b) Granary and grain - 1 bag of rice
 - c) Documents - 10th Class to Master certificate, birth certificates, report cards.
 - d) Vehicles - 2 wheeler (Pleasure), Gyar cycle, plain cycle
 - e) Furniture - Sofa, 4 table, dining table, steel almirah, drawers
 - f) Traditional ornaments - Traditional necklace
 - g) Modern & traditional garments - 20 shawls, 37 traditional ~~piece~~ attire.
 - h) Gas book - Misao Gas
 - i) Electronic items - computer set (2), (2) TV set, 3 phones, rice cooker, dispenser refrigerator, washing machine, boiling steam
 - j) Other - Cylinder (5), Gas stoves, jumbo boxes (2), Syntax, 4 bite.
- Total loss of properties at my residence would be above Rs 80,00,00 (Eighty Lakhs)

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I have lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
