Subject: FIR on Destructions of Khongsai Veng, Imphal East, H.No. 72
on 4th May, 2023 at 3:00pm by Valley base miscreant.

Sir,

I am to state that, on 4th May 2023, at around 3pm, our locality Khongsai Veng, Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. 72 (Permanent Residence) was also destroyed by the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed includes:

1. Immovable properties like House having **Pucca House(2 Storey Building)**
2. Movable properties
 - a) Gold & jewelry **3 Gold Necklace(8-san)**
 - b) Granary & Grain **7 Bags of rice grain 5 bage rice bage**
 - c) Documents. **House Plot Patta Certificite, Bank Passbook, Other Documents Etc.**
 - d) Vehicle **I20 Car (MNO1X7002), 2 wheeler TVS (MN01U-7869)**
 - e) Furniture **6-seleping beds 3 wooden almirah dressing table etc**
 - f) Traditional Ornaments **5 traditional ornaments**
 - g) Modern and traditional garments. **NIL**
 - h) Gass book **04 cylinder gass stove etc**
 - i) Electronic items. **Smart phone 3 laptop computer 2- Digital Camera**
 - j) Cash. **27 Lakhs**

Total loss of properties at my residence would be above Rs. **1,27,60,000/-**

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to safe myself and my families from the rioters.
