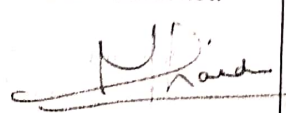

Sir,
I have the honour to state that on 4th May 2023 at around 3.00 pm some unknown miscreants belonging to Meitei Yantho Org. suspected to be members of Akambai Tenggol who are loyal group to the present Inner MP, Shri Leishemba Sanayacha, World Meitei Council (WMC), Meitei Leepul and Kanglipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC) numbering about 1000+ members carrying sophisticated weapons AK rifles, 303 rifles, S&BL Pistol Molotov, etc. with vehicles forcefully attacked my house located Khongsai Veng, Imphal East, Manipur and looted all valuables and Burn my house. Vandalized all moveable properties and leaving us homeless. The approximate value of lost and destroyed properties are:

1. House NO.1 two story Rec. SSX75 - INR 23,000,000/-
2. Furnitures, Jewellery, Electronics etc. - INR 99,45000/-
3. Vehicles i. Royal Enf. MN04G4669 - INR 2,12,000/-
ii. Honda Mav. MN01AL2844 - INR 1,16,999/-
iii. XUV-300 Car MN01AS4096 - INR 17,26000/-
