properties

Sir,

I am to report that on 4th May, 2023 at
about 3-00 pm our locality Khongrai Veng, Laiphom
Khunou, under Lamphel Police Station was attack
by a large number of unknown miscreants
belonging to the Meitei community with the
intention of murder, arson and looting.

As a result of which my properties
shown below are burnt, destroyed and looted.

1. Dwelling house four rooms alongwith all
properties inside it like - Frate TV, Steel bedroing
almirahs - 3 nos, sofa set, beds, clothing for wearing
apparels and beds, all utensils, furniture etc
2. Various service related and my childrens'
documents etc
3. Gas cylinder - 4 nos and documents
4. 1 (one) Auto car bearing registration - MV04A-4995

Total estimated approximate value = Rs 70,00,000

I therefore request you to kindly take up
necessary legal action against the unknown
Meitei whoever else are related with the
incident and brought them to justice at the
earliest.

The matter could not be reported in time as
all our locality fled for our life and took
shelter at different places. On arrival at Kangpokpi
district headquarters I can only lodge this
report at your P.S.
