Subject: Report against Arson attack of moveable and immovable properties that took place on 4th May, 2023 at about 11:00 AM at Langol, Imphal within Lambel P.S.

Sir,

I, the undersigned, a victim and refugee taking relief / shelter at Churachandpur at present have the honour to state the following for your kind intervention and favourable action that, on 4<sup>th</sup> May 2023 at around 11:00AM, unknown mobs from the Meitei community armed with deadly sophisticated weapons viz., automatic guns like Ak-rifles, SLR, machete/ sword, iron rods, etc. came which compel us to ran for our life. The said Mobs forcefully vandalized and looted/ robbed our house, and they have stolen our Maruti Alto Car bearing Regd. No. MN01AG 8434 and our two wheeler Activa bearing Regd. No. MN01-9050 parked inside our house premises. The brief description of our properties are given hereunder:

- (1) Immovable property Concrete residential building.
- (2) Moveable property (i) All the domestic goods inside the house and
  - (ii) A Maruti Alto Car Redg. No. MN 01AG 8434
  - (iii) An Activa bearing Redg. No. MN01-9050

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 11,16,387/- (Rupees Eleven lakh Sixteen thousand Three hundred and Eighty Seven) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
