Sir,

This is to inform you that on the 4th May 2023 around 10:20 AM. unknown miscreants attacked our Groceries store and House which we rented at Lamphel Sanakeithel owned by Dr.Kubel Near Bryan Medical Store. The miscreants forcefully entered our houses and damaged our properties. They also looted all our belongings including my house, grocery shop and my two wheelers Suzuki Blue colour bearing Regd.No. MN 01 AD 4718 under the name MANGKHANTHANG and electronics items such as Three(3) Laptops, Xerox printer, furnitures, mattress, kitchen appliances, family heirlooms, clothes etc. In addition the house in Mantripukhri Lamlongei Lane No.8 were looted and completely destroyed. Both the damaged and looted properties estimated around 90 Lakhs(Ninety Lakhs only).

I request you to kindly registered the complaint and look into the matter and do the needful as soon as possible.
