

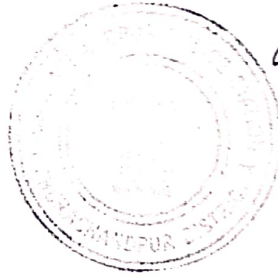

Subject : Report on damage of property and burning of house/building at Paite veng,
Sangaiprou, Imphal west.

Respected Sir,

As stated above, i would like to report that my house/building and property located at Paite Veng, Sangaiprou, Imphal West bearing patta No.137 and Dagh No. 92/234 covering an area of 0.0800 acre was damaged and set on fire by a group of unknown miscreants on the fateful night of May, 03, 2023 (Wednesday) at around 07:00PM.

The detailed lists of property damaged are given below:

1. I(one) Storey Pucca Building with 12 rooms and 9 toilets covering an area of 80x35 sq.feet with an estimated cost of Rs.1,60,00,000.00(One crore sixty lakhs only)
2. Pucca Fencing covering an area of 85x35 sq.ft with an estimated cost of Rs. 30,00,000.00 (thirty lakhs only)

The said incidents falls under the jurisdiction of Imphal West Police Station but it is not possible to lodge an FIR at Imphal West due to the prevailing situations. Therefore, I kindly request you to register an FIR on the above cited incidents and booked the culprits as per the law(s).
