Today i.e. 26/6/2023 at 6:30 pm received an information from SP-IW control room that on the same day at about 6:10 pm some unknown miscreants have ablaze 2(two) vehicles i.e. one Dutsan Go Car and one Breeza car driven by two local Meitei Pangal (Muslim) which was taken out from 143 CRPF Bn. Camp Lamphel after coordinating with the camp commander in that matter some unknown miscreants had intercepted and detained the duo driver involved in transportation of the said vehicles near Naoremthong Laishram Leirak area and kept confined at one community Hall of that area and also burnt down one vehicle. On receiving the same information team comprising OC Lamphel, two teams of Lamphel PS, mike 23 rushed at the said place and intervened in time to rescued the two drivers unharmed. Later, they were identified as one 1) Md. Amir Khan 29 Yrs s/o Md. Ayub Khan of Keirao Awang Leikai and 2) Md. Hasan 27 Yrs S/o Md. Anwar of Keirao Makha Leikai. However, both the vehicles are burnt down one after another by the unknown miscreants at different location while engaging on rescuing the Meitei Pangal (Muslim) drivers.

Hence, the Suo-Moto case under FIR No. 786(6)2023 LPS u/s 435/365/347/427/120-B-IPC has been registered for investigation.
