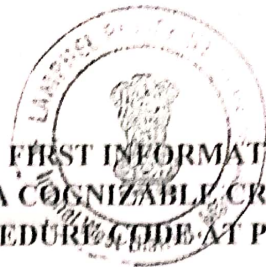



Sub: Request for lodging of FIR case regarding ransacking/burnt down of my house located at Moreh on 3rd May 2023 - reg.

Sir,

1, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Moreh Town on 3rd day of May 2023 at around 4.30PM. The said unidentified groups vandalised/burnt down my house and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs 25,39,800/- (Twenty five lakh thirty nine thousand and eight hundred only).

2. In this regard, it is requested that kindly initiate and take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action.
