us alive.

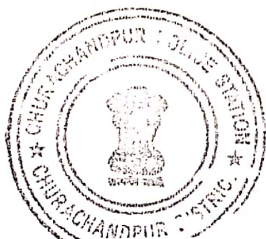
I request you to take strong actions against the perpetrators by registering
