Subject: Complaint regarding acts of vandalism, arson, theft and looting registration of a Zero FIR.

Sir,

With reference to the subject cited above, I would like to lodge a complaint regarding the attack unleashed by a violent mob allegedly belonging to the Meitei/Meetei community on our properties and personal belongings in the early hours of the 4th of May, 2023 and which continued sporadically thereafter at my rented premises at 'Salem House', Paite Veng, Sangaiprou, Imphal West - 795 001, Manipur.

In the mayhem, the miscreants burnt three vehicles, one of which is a Government vehicle (a white Maruti Suzuki SX4 bearing registration No. MN01S 1244) and two private vehicles (a dark brown Datsun Go bearing registration No. MN01AK 0399 and a white Maruti Suzuki M800 bearing registration No. MN02 4774), Educational certificates/records (Matriculation, Class XII and Graduation certificates), PAN Cards, College ID Cards, Medical records and personal belongings of all the family members, viz. Mrs Chingzaning Hangzo Songput (wife), Ms. Sara Lhingsianvung Songput (daughter), Ms. Salome Vungthianching Songput (daughter) and Ms. Songput Kimneih Claire (daughter). Besides these, a large sum of cash, gold and diamond jewellery, gold coins, papers/documents relating to Mutual Fund investments and Insurance Policies, three Television sets (Sony 55", 43" and 21"), wooden furniture (teak sofa set), a wooden teak Diwan and four Laptops, one of which is a property of the NHP (Manipur IA), Passport of the undersigned and PPO booklet (Pension Payment Order No. 112224709) are missing (A detailed list of the properties and personal belongings is attached as an Annexure).

When the marauding mobs attacked, we are compelled to flee and had to take shelter in the 1st Battalion Manipur Rifles' Relief Camp. As we no longer feel safe in Imphal and as our rented premises have been burnt down, we have no choice but to relocate to Churachandpur.

In view of the above facts and circumstances, you are requested to kindly:

i) Register a Zero FIR.

ii) Facilitate an investigation into the events prior to and leading to the incidents of vandalism, theft, arson and looting and book the culprits immediately so as to prevent the recurrence of such undesirable incidents in future.

Thanking you in anticipation as I look forward to a favourable consideration of my request for registering a Zero FIR at the earliest.
