Sir,

I am to report that today i.e. 28/01/2023 at 04:30 am, an information was received by source of 16 AR about some Over Ground Worker of valley based underground loitering at Thanga Heisnam Leikai area for their prejudicial activities. Based on the information, an Operation was launched with my team assisted by Hav. Th. James Singh of CDO-BPR under the command of Sub. Y. Shaktishen Singh, OC-CDO/BPR and under the supervision of Roni Mayengbam, MPS, Addl. SP(Ops) BPR with overall guidance of N. Herojit Meetei, IPS, Sr. SP-Bishnupur, immediately rushed to the said area and conducted house to house search of suspected persons at around 5:30 am. During the search, one unknown person was detained on suspicion at Thanga Heisnam Leikai. On spot verification, the unknown person identified himself as Heisnam Jiban Singh (45) yrs s/o (L) H. Kulachandra Singh of Thanga Heisnam Leikai.

On further verification, he disclosed that, he is an Over Ground Worker of KCP (Kangleipak Communist Party) working under the command of one Ningtamba of KCP presently staying at Veng Churachandpur, he further disclosed that he collected some amount of Rs, 50,000 (fifty thousand) in Indian Currency from one Ima Kiranbala of Toupokpi for their fund of the party and send it to Ningtamba through passenger bus to Churachandpur. So, he was arrested at 6:30 am from the spot by observing formalities. Conducted his medical checkup at CHC Moirang, as well as Covid test at PHC, Thanga and handed over to the Officer-in-Charge of Keibul Lamjao Police Station at 11:30 am for further necessary legal action.
