



Sir,


I am to report that today i.e. 10/03/2023 at around 10.30 am based on the input received from 16 AR about the presence of Karangjao of KCP/URF at Karang in relation with FIR No. 43(3)2023 SJM-PS U/S 20 UA (P) Act dated 09/03/2023, I along with my team under the command of Sub. Y. Shaktishen Singh, OC-CDO/BPR and under the supervision of Roni Mayengbam, MPS Addl. SP (Ops) Bishnupur under the overall guidance of N. Herojit Meetei, IPS, Sr. SP-Bishnupur with a column of 9 AR immediately rush to the said location and conducted searched.

During the course of search, he was detained for verification at Khumanpokpa playground, Karang. On spot verification, he identified himself as Oinam Somenchandra Singh @ Moirangjao @ Karangjao(38) S/O O. Rajen Singh of Karang Mamang Leikai, Bishnupur District. On questioning, he disclosed that, He is an active cadre of KCP/URF joined in the year 2004 through one Jet from Moirang of KCP. On questioning about the Lathode gun and two Lathode shells which was recovered from Laishram Tiken Singh, He disclosed that, He had handed over the above mention arms and ammunition to Laishram Tiken Singh on 25<sup>th</sup> February, 2023 for selling to one hill based underground organization at the price of Rs. 1,10,000/- (one lakh and ten thousand). So, he was arrested from the spot at 1.10 pm and seized one Redmi 8A having one airtel SIM card bearing mobile no. 9378006319 at 1.15 pm by observing necessary formalities.

The arrested person mentioned above along with the seized mobile phone are handed over to you for taking further necessary legal action against him.
