Subject: - Report

Sir.

I have the honour to report that on 04/12/2023 at around 10.30 pm, while I along with my team were conducting random frisking and checking of vehicles plying along NH-37 at Leingangpokpi village, Jiribam area near Phaitol village under Tousem Sub-Division Tamenglong District, Manipur, one Maruti Gypsy bearing regd. No. MZ 01 D – 3497 came towards the frisking and checking point from Imphal side towards Jiribam driven by one unknown driver and the vehicle was stopped for checking. On checking of the vehicle, all the front and back windows are found with tinted cover glasses and also found 2 (two) male occupants and the 2 (two) female occupants inside the vehicle (including the driver). I introduced myself to them as SI. A. Krishna Sharma of Special Mobile Patrol Unit, Jiribam District Police.

On verification of the occupants of the vehicle one after another, they identified themselves as (i) Mr. Semminthang Haokip (41) S/O (L) Tingthang Haokip of Tingtong Laijang near Kotlen village, Veitum Khullen, P.S. Sapermeina, Dist. Kangpokpi, Manipur A/P Aijalon near Tuibong, Churachandpur (driver of the vehicle), (ii) Mr. Ngamkholal Haokip (35) S/O Jamthang Haokip of Wakan Village near Leitanpokpi Sagolmang A/P Changlei Village near Mulnom Churachandpur, (iii) Mrs. Nengjahat Khongsai (37) W/O Khupneilal Khongsai (27) Lalboi of Kaprang - Luiphai village P.O, P.S & Dist. Churachandpur, Manipur, and (iv) Mrs. Neikhohei Kipgen (45) W/O Ngamkhothang Kipgen of Dampi Moljang Village P.O, P.S & Dist. Churachandpur, Manipur. Further, on checking of the vehicle, the front left & right door window glass was stuck and couldn't be pushed down. On the spot questioning, they disclosed that contraband drugs are kept conceal inside the vehicle.

Immediately, the matter was informed to Shri. Thomas Thokchom (MPS) ASP (L/O) Jiribam and OC/Jiribam Police Station. Subsequently, Shri. Thomas Thokchom (MPS) ASP(L/O) Jiribam and a team of Jiribam Police Station including women constable no. 0123033 Saida Haque Choudhury had arrived at the spot. Due to late night and the present law & order situation, the vehicle and the above mentioned persons were brought at Jiribam Police Station for thorough checking. The matter was also informed to Executive Magistrate Jiribam Shri. Moirangthem Devananda Singh. On his arrival at Jiribam Police Station, thorough checking of the vehicle was conducted in presence of the driver and all the occupants. On opening of the left side window dash board, 10 (ten) nos. of soap caps containing brown colour powder (suspected to be contraband drugs) were found and on further opening of the right side window dash board again, another 10 (ten) nos. of soap caps containing brown colour powder (suspected to be contraband drugs) was found.

Further, all the 20 (twenty) nos. of soap caps were marked as A-1 to A-20 and simultaneously weighed by using weighing machine and found as "A-1 = 13.54 grams, A-2 = 13.65 grams, A-3 = 12.67 grams, A-4 = 12.76 grams, A-5 = 13.24 grams, A-6 = 12.50grams, A-7 = 13.49 grams, A-8 = 12.65 grams, A-9 = 12.44 grams, A-10 = 12.42 grams, A-11 = 12.35 grams, A-12 = 12.48 grams, A-13 = 12.28 grams, A-14 = 12.85 grams, A-15 = 12.07 grams, A-16=12.37 grams, A-17=13.01 grams, A-18=12.15 grams, A-19=12.23grams, and A-20 = 13.37 grams (in total 254.52 grams excluding the weight of soap caps)".

Then, all the soap caps i.e. "A-1" to "A-20" were put inside a cartoon box and wrapped with plain white cloths with packed & sealed by using wax with a five rupee coin and marked as "P" as parent packet. Thereafter, all the 4 (four) above accused persons and the Magistrate and all the witnesses have appended their signatures on that parent packet "P" (due to late night no civil witness were available while observing the formalities). As such, the parent packet "P" containing brown colour powder (suspected to be contraband drugs), the vehicle Maruti Gypsy bearing regd. No. MZ 01 D-3497 and 4 (four) nos. of Mobile phone used by the accused persons including sim cards (model - Redmi note 10, Realme aca139485, Redmi 8A and Nokia keypad 1304 respectively) were seized from the possession of all the above accused persons by preparing a formal seizure memo at 12.30 am (of 05/12/2023) in presence of Executive Magistrate and the witnesses who all have appended their signatures on that seizure memo. Accordingly, the above 4 (four) occupants of the vehicles including the driver were arrested at 12.40 am (of 05/12/2023).

The arrested accused persons and the seized items are hereby handed over to you for taking further necessary legal action.
