Subject: - Report

Sir,

I have the honour to report that today i.e. 10th October 2023 at around 1:30 pm, I along with a team of Lamlai Police, under the supervision of Shri. M. Binodkumar Singh (MPS) OC, Lamlai PS was conducting random frisking and checking at Leimakhongmapal near dam along NH 202(Imphal Ukhrul road). At around 2:50pm, one Alto car black in colour bearing regd. No. DLSCC-5971 which was coming from Imphal side towards Yaingangpokpi, driven by one unknown driver was detained for verification. On verification of the driver, he identified himself as Keisham Nongpoknganba Meitei (23) S/O K. Koireng of Yaingangpokpi Awang Leikai P.O Lamlong, PS Yaingangpokpi Dist. Imphal East, Manipur. Being suspicious the matter he was given an option whether he would like to check his body in presence of Executive Magistrate/gazetted Officer or civil witnesses. In that, he offered to check his body in presence of gazetted officer, then I informed to Shri. M. Binodkumar Singh (MPS) OC, Lamlai PS for witnessing while observing formalities. Thereafter arrival of Shri. M. Binodkumar Singh (MPS) OC, Lamlai PS mean while no civil witnesses were available at the time of checked, at the spot. I have carried out thoroughly body search. On searching one soap cap light blue in colour was found on the left half pant pocket worned by him. On opening the said soap cap and found brown colour powder inside the transparent plastic pouch which is highly suspected to be contraband item (brown sugar). And marked as 'A'. Then, I have arranged one weighing machine from nearby the shop, and on weighing the said contraband item and found 10 grams (without the weight of soap cap). Then, the above marked item i.e. A was wrapped with white colour cloth with packed and sealed and marked as "A" in presence of accused person and civil witnesses.

Thereafter I have seized the said soap cap containing suspected contraband item along with the above vehicle and one mobile handset Real Me Narzo along with Jio sim in presence of the witnesses at 3:00 pm by preparing a formal seizure memo. Later the said detainee also arrested at 3:10 pm by preparing formal arrest memo.

Therefore the apprehended individual and the seized items are hereby handed over to you for taking further necessary legal action.
