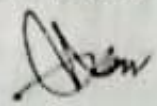

Subject: - Report

Sir,

I have the honour to report that on 19/10/2023 at about 11:00 am my younger brother namely Md. Sahir @ Sana (43) yrs S/o (L) Abdur Rahim of Kshetri Bengoon Awang Leikai went out our house on his vehicle TATA Super ACE bearing regn. no. MN01S 5407 saying that he will be transporting cattle from Takhel to Hatta Golapati hired by one Mrs. Sana W/o Md. Firoz of Hatta Golapati. He was accompanied by Mrs. Sana, Mrs. Bito W/o Manglem of Kanglatombi and Abir Khan of Sora. The cattle was to be picked up from the residence of Nganbi W/o Nanao of Takhel, Madilok.

On reaching the residence of Mrs. Nganbi W/o Nanao of Takhel Madilok at about 1:00 pm they were beaten black and blue by some unknown persons. As a result of which my brother was seriously injured on his person and evacuated to hospital. However, after continuous treatment at Raj Medicity, he could not recover and died at the hospital today as informed by the concerned doctor.
