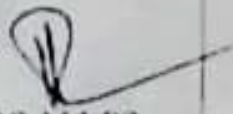

Today i.e. 06/12/2023 at 4:50 pm received a reliable information that on the same day at about 4:40 pm one unknown TVS Jupiter Scooter ridden by unknown person coming from Lamlong side towards Sawombung side and an unknown Yamaha R15 motorcycle ridden by unknown person which was coming from Sawombung side towards Lamlong Side collided at Chingarel near L. Biren Carpentry Industry along NH 202, Imphal-Ukhrul road. As a result of which the unknown TVS Jupiter scooter rider and the Yamaha R15 motorcycle rider and the pillion rider received injuries on their persons and evacuated to Hospital for medical treatment.
